Repairs to the rural water line were discussed, along with flood damages, the FEMA application that will be submitted to help aid the city with the cost of the damages, East High Street repairs and sealcoating, the storm sewer annual cleaning and contract, repairs needed to the alley behind Weaver Street, and sidewalk repairs by Westerville Street.
